**January-April and October-November**

**Rules, Players, Pairings and Course Information**

1. **Golf League Coordinator** Diana Williams 207-380-7144
2. **\$10 per person entry fee**: All money is disbursed as monthly prizes at the Castleberry Circle Club meetings.
3. **Pairings and Dates**: See Pairings Sheet: Each match will be played with the specified pair during the month. Each pair (not necessarily the first team listed) will be responsible for scheduling their match on the designated course during the given month.
4. **Rain/Thunderstorms**: If you are forced off of the course due to heavy rain and/or thunderstorms and lightning, you may complete your round on a later date. For example: If you have completed four holes, you must use the score from those completed four holes from the original date of play. The scores from the last five holes would then be played on a subsequent date. The score card should indicate the different dates of play.
5. **\*Substitutes**: If you cannot play your match, it is your responsibility to find a substitute. Substitutes must be current members of the Castleberry Couples Golf League. If you absolutely cannot find a substitute, your match can be played with 3 players. In that case, each of the 3 players would substitute for the missing player on 3 holes, in rotation. Example: Player 1 hits 2 balls on holes 1,4 and 7; Player 2 hits 2 balls on holes 2, 5 and 8; and Player 3 hits 2 balls on holes 3,6 and 9.
6. **Play format**: The format for each monthly round is a 4-player Scramble. Each player drives from every tee. No Mulligans are allowed. Whiffs count as a stroke. As a team, you choose the Best Ball, and everyone hits from that location. This format is repeated until the ball is holed. (Exception: See Rule #8 below regarding maximum drives.) The score equals the number of times the foursome hits to get the ball in the hole. (Example: Dee's tee shot is chosen- That's 1 shot. All players then hit from the location of Dee's drive- That's 2 shots. John's shot is then chosen as Best Ball, and all players hit from that location. That's 3 shots. Mary putts the ball into the hole-That's 4 shots.
7. **Teeing Ground**: Men should use the middle tees. Women play from the Green tees. Men over age 80 may choose to play from the green tees.
8. **\*Drives**: No individual player's drive can be used as Best Ball more than four times per round, including drives made for an injured or absent player. Clarification of this rule was needed in 2025. So....after much research: Here's what ChatGPT says: **If fewer than four players are able to tee off for the entire round, the four-drive maximum applies only to the players who are actively participating. The rule follows the USGA guidelines. More of the content from ChatGPT is included below.

9. **Scorecards:** see **Sample Scorecard**. Please note Date of Play at the top of the scorecard. Scorecard should show the names of all player, team numbers, plus whose drive was chosen as Best Ball, and Total score. If substitute(s) are used, list the name of the sub, not the original player. Scorecard should be signed by a member of each couple.
